

NEW TO ALBERTA: STEPS TO OBTAINING AUTO INSURANCE & REGISTRATION

Welcome to Alberta! Obtain insurance, your Alberta driver's licence and register your vehicle all at one location. Four of our eight locations offer both Alberta Registry services and insurance services.

You will require Acceptable ID for all of the following.

1. Phone your previous **provincial insurance carrier** to obtain a **driver abstract** and insurance **claims experience** letter. Note that if you were previously insured with a private insurance company you should contact your prior brokerage. These documents are required **before** Alberta insurance can be put in force. (*See below for a list of contact numbers.*)
2. Obtain an insurance quote from a **Drayden Insurance office** <https://drayden.com/contact-us/locations> (eight locations to serve you). Have the documents from step #1 faxed or emailed to our office.
3. At our Registries office:
 - a. Obtain an **Alberta driver's licence**. <https://drayden.com/registry-services/drivers-licence/>
 - b. Request an **Out-of-Province Inspection form**. <https://drayden.com/registries/registering-a-vehicle-from-out-of-province/> **exemptions for BC, SK and MB may apply*
4. Complete the application for auto insurance at Drayden Insurance (started when obtaining a quote in step #2). An Alberta driver's license number will be required. You will require this proof of insurance in order to register your vehicle.
5. Return to our Registries office to register your vehicle. Bring with you the following:
 - a. Valid Out-of-Province Inspection form (If applicable).
 - b. Proof of Alberta Insurance.
 - c. Vehicle registration from previous province (you must bring this in again).
 - d. All parties listed on registration must sign.
